Share the Lake day was a big success. There were 34 guests from the Bigfork Nursing Home. Eight or nine students from the honor society were a big help. No date has been set for next year yet.

Mike Nystrom reported on the 4th of July boat parade on Little Jessie. They have been doing it since 1976 and have 22-30 boats participate. They have coffee and cake following the parade. Hollister and Jerril Madsen have offered to coordinate a parade on Big Jessie for next year.

Mike Nystrom reported that he found purple loosestrife, an invasive species, on Little Jessie. Soil and water checked but only found it in the one area. We all should be aware and if it is found pull it out. There is state funding to fight invasive species, concentrating on highest priority lakes. A one day inspection was on Jessie, but there were no boats. The DNR is also doing inspections. If you notice any problems, call the tip line. The board will discuss other monitoring ideas.

Mike Nystom attended the Healthy Watershed Conference and reported on some of the break out sessions he attended.

Jerry Kaczor will be paid to trap beavers again this year.

Northerns affect the walleye populations. In 2016 there will be a slot on northerns.

The lake level today is the same as May 11. It is down 2-1/2inches from last year.

Two loon chicks were counted on the North end of the lake and one on the South end.
